Revised Installation of Height Control Valve for FLEX Air™ Rear Suspension

This bulletin is applicable to all vehicles built on and after December 17, 2001 and equipped with a FLEX Air<sup>TM</sup> rear suspension. It summarizes the changes in the mounting of the height control valve (HCV) for this suspension.



NOTE: No changes to valve plumbing or servicing procedures are caused as a result of this revised HCV installation. Similarly, the procedure for setting and adjusting ride height and pinion angles on the above vehicles is the same as currently presented in <u>F.S.B.#6-01</u> and <u>Section 6. "Rear Suspension"</u> in the master maintenance manual.




Figure 1 Illustration of FLEX Air HCV Mounting Bracket Installation Before 12/17/01

A design improvement that enhances the overall *FLEX* Air suspension installation was implemented in production on December 17, 2001. The location and orientation of the HCV mounting bracket was changed so that future *FLEX* Air suspensions will now use the same HCV/bracket assembly as do all other Peterbilt proprietary rear air suspensions (see Parts Notes below). Figures 1 through 4 illustrate these changes:




Figure 2 Illustration of FLEX Air HCV Mounting Bracket Installation On And After 12/17/01

- <u>Figure 1</u> and <u>Figure 2</u> illustrate the original and revised HCV mounting bracket locations, respectively. The bracket is now inverted (the bracket leg now faces forward) and is mounted higher on the frame rail to clear the lower flange of the frame rail. [NOTE: Because of this change in mounting height, the vehicles noted above require a new, longer HCV link assembly (see Parts Notes below).]




Figure 3 Improper Installation of HCV Bracket Mounting Bolts ("Head-Side Out")

- <u>Figure 3</u> and <u>Figure 4</u> illustrate the reversing of the orientation of the HCV bracket mounting bolts. Bolts are now installed "nut-side out" to prevent interference between the bolt and an air bag installation tool (90-degree air ratchet).
